1. Call to Order

Chairman Fitzgerald welcomed members and called the meeting to order.

Mr. Valdes stated that there is a lot to cover at today's meeting. There has been activity on the broadband connectivity strategy, the 2023 TIP Update and details of the Federal Certification Review scheduled for July 13-15, 2021.

RESOLUTION OF THE EXECUTIVE COMMITTEE OF THE SOUTHWESTERN PENNSYLVANIA COMMISSION to certify that the work products associated with PA DCNR Grant BRC-TAG-22-190 (the SPC Regional Natural Heritage Inventory Update) have been completed in accordance with the

existing grant agreement between DCNR and SPC. The final county Natural Heritage Inventory Reports and associated data have been completed and provided to the SPC counties.

WHEREAS, SPC was granted funds from DCNR for the update of the Region's Natural Heritage Inventory in the amount of \$88,000.00 in December of 2016 and entered into an approved grant agreement in February 2017;

WHEREAS, the SPC in collaboration with the Western Pennsylvania Conservancy has updated the NHI dataset and finalized new county NHI Reports in all of SPC's 10 Counties;

WHEREAS, the update included communication with a stakeholder committee that was open to representatives of each of the member jurisdictions, the SPC staff and WPC staff provided updates on the project to the stakeholder committee and the SPC Transportation Technical Committee throughout the project;

WHEREAS, SPC staff and WPC staff held a final wrap up event virtually on March 9th 2021. After the event the final county Natural Heritage Inventory final reports and geodatabase was made available to all stakeholders for download; and

WHEREAS, DCNR requires a documented resolution by the governing body of the grantee to complete the administrative closeout of the Grant.

NOW, THEREFORE, BE IT RESOLVED that the Executive Committee of the Southwestern Pennsylvania Commission certifies that the work products associated with the PA DCNR Grant BRC-TAG-22-190 (the SPC Regional Natural Heritage Inventory Update) have been completed in accordance with the existing grant agreement between DCNR and SPC.

Mr. Massaro thanked Mr. Valdes for his kind words. I have worked at SPC for 32 years and it has been a great experience and I will miss everyone tremendously. Thank you.
