- 1. Chairman Fitzgerald called to order the August 30, 2021 meeting of the Southwestern Pennsylvania Commission.
 - Quorum There being a quorum present the meeting proceeded
 - Any Conflict of Interest Declarations on Action Items None
- 2. Action on Minutes of the June 28, 2021 Meeting

A motion was made to approve the minutes of the June 28, 2021 meeting by Leslie Osche which was seconded by Mike Belding. The affirmative vote was unanimous.

- 4. Financial Report Vince Massaro/Margaret Fonner
 - 1. Preliminary work on the staff side is done, schedules have been completed
 - 2. We anticipate a draft report by the end of October
 - 3. This is last financial report for Vince, introduction to Margaret Fonner

5. Presentation by TESIAC – Matthew Lesh/Andrew Morgan

- 1. The origins of TESIAC is the outgrowth of decades of experience among its founders in finance renewables, energy and public and governmental policy
- 2. Focusing on mobility, energy, technology and the integration of those systems bringing private capital and putting it to work alongside of public funds.
- 3. Business model is predicated on partnerships and alignment with the stakeholders, bringing the physical and digital worlds together.



4. By intergrating and providing interoperable capabilities that this will be a multiplier in terms of the return on investment for the communities.

Any questions or comments? – Vincent Valdes: "I just wanted to mention that for me one of the things I had committed to was to bring new ideas to the commission and the region. I think what we're seeing and you'll see it also in the next presentation from Stefani and Matt, that the federal government is really looking for us all to consider ourselves more closely aligned as a region. They're looking for that regional voice and I'm looking for tools, I'm offering ideas to all of my stakeholders here, so that you are aware of what's going on beyond our region. Something for us to consider as a region, there are new tools, new ways of doing business and there are reasons for doing that as we will see in the following presentation from Stefani Pashman and Matt Smith."

- 6. Discussion of EDA Grant Coalition Stefani Pashman/Matt Smith
 - 1. Looking for opportunities to strengthen the region and think about ways to propel the economy forward.
 - 2. One catalytic opportunity coming out of the Economic Development Administration of the Department of Commerce is the Build Back Better Regional Cluster Challenge it's a billion dollar challenge coming out in two phases and we have 90 days for the first deadline.
 - 3. The phase one propsal could yield half a million dollars toward a several month opportunity. It could really move the regional ecomony forward.
 - 4. There will be 50 or so first round grants.

Matt Smith said it's going to be really, really important as we move this application forward, and then move on as you said Vincent the infrastructure, energy and workforce development opportunities that might be available out there.

Mavis Rainey asked if either you or Vince could look at making this as equitable as we possibly can that would be great.

Vincent Valdes explained that it's baked into the process. I think it is giving everyone the opportunity to contribute to what the vision is. It's very clear from this particular grant application, or grant opportunity, and from what I'm hearing from the ones coming from Washington D.C., equity will be a part of the equation. But equity is a broader definition, it also means communities that may not have been able to be at the table before, for example: rural communities or people that have been unemployed for a long time, as well as communities that are a part of urban centers that have not been at the table. So again, they're asking everyone to think expansively about what these definitions are. And we're going to provide the means in which people can communicate with us and connect to this process. We're also setting up a number of opportunities for being able to provide input. Jenn Lasser described it in the Executive Committee meeting. On September 8th, we'll be talking to municipalities and local governments. We want to start talking to no traditional partners as well. We have to think expansively; we have to think about the housing implications and perhaps community redevelopment in parts of the Mon Valley. So again, we need to think regionally in order to be able to take advantage of these opportunities because they will be rare. I don't think that we'll be seeing this again any time soon.

Chariman Fitzgerald stated that it seems to me our chances are much better if we reach a consensus, so that we're speaking with one voice. If we coalesce around the project or projects that will build economic growth, the equity part of it could include a lot of different things, connecting people to it, skill enhancement are the various aspects we can build upon. And I think that thinking about these shovel ready or close to projects that might even be already underway, but you don't have the ability to finish the final connection, or the final part of it is incumbant upon all of us to get this to Stefani, Matt and Vince, so that we can reach a consensus on what we're going to go to Washington about.

I-79 Widening and Interchange Improvements

- I-79 3rd lane widening from Alpine Road to Prestley Road for an approximate length of 2.5 miles. Including mainline I-79 bridge widening / replacement / preservation
- Bridgeville Interchange reconfiguration
- SR 50 improvements and traffic signal upgrades between (Washington Pike) and the Hickory Grade Road intersection to accommodate ramp and bridge improvements
- New retaining walls and replacement of six existing sign structures are proposed along 1-79



 - o Interchange improvement on I-376 at the Squirrel Hill Interchange west of the Squirrel Hill Tunnel in the City of Pittsburgh, Allegheny County, Reconstruct and realign on and off ramps eastbound to eliminate weaving movements, reduce crashes and improve merging. Improve westbound of framp approaching overhead structure to improve operations for large trucks going around the curve.


Air Quality Conformity - Ozone

3. The pink areas on your screen and the map and the charts on the left top line is the motor vehicle emissions budgets and the bottom lines are the modeled emission levels with these projects added in, well below the emissions budget.

Chairman Fitzgerald asked if the three projects you outlined, in addition to the name change of 376, we're not making a vote here to how the projects are funded, that's up to PENNDOT and Harrisburg to figure out, what we're saying is we want these project on the TIP. Is that correct? Andy Waple said that is correct. The funding for SR 356 is coming through the allocation that we get as the SPC MPO of our state and federal formula fund. Moon Township is locally funded through their transportation authority and you're correct on I-79. We're simply saying that we want PennDOT District 11 to begin to design these projects and investigate impacts to the local municipalities in the local roadway system. It has no bearing on the funding of that project.

Chariman Fitzgerald asked if there were any questions; hearing none, he asked for a motion.

A motion was made to approve Resolution 11-21 by Leslie Osche and seconded by Larry Shifflet. The affirmative vote was unanimous.
