### <u>City of Pittsburgh – Crash Data Dashboard</u>

Panini presented the City of Pittsburgh's publicly accessible crash data

- Demoed the web tool to show its capabilities to refine, and analyze crash data from 2018-2023 by neighborhood
- Explained the availability of multiple visualization techniques that provides the user dynamic ways to explore the data sets
- Answered a question about the availability of bus crash data on the dashboard

## How to Make Sense of Bus Transit Automation – Policy Paper

Nik Martelaro and Sarah Fox presented on the utilization and development of autonomous bus transit technologies. They reviewed the current applications of vehicle automation in transit including rail, shuttles, vans, electric buses, and personal vehicles. Followed by a geographic representation of where pilot initiatives in the US have taken place in the past and as well as locations with future plans to test Bus Transit Automation.

- Recommendations were provided for a new training program that intends to provide human operators of autonomous vehicles with the tools they need to safely maneuver the vehicle in emergency situations.
- Discussed burdens of "Automation surprise", mode error, authority control, and skill atrophy.
- Highlighted the responsible parties when problems arise
- Leveraged air transits success with automated systems serving as an example of how automation technology can be used to increase the safety and efficiency of a transit mode.

## SPC's US DOT Safe Streets and Roads for All (SS4A) Grant Application

Josh Spano reviewed details for the Safe Streets and Road for All Grant Program. Which provides \$1 billion in funding for fiscal year 2023-2024. Funding will be dispersed with a required 20% match by the MPO's, counties, cities, towns, State Transit Agencies and Tribal Governments. This funding is intended to be a resource for perspective projects that improve roadway safety by significantly reducing or elimination roadway fatalities and/or serious injuries.

- Presented the Pilot Comprehensive Safety Plan for Allegheny County
- The pilot was developed with the Vision Zero Plan that focuses on utilizing methods of analysis, equity, public engagement, and outcomes
