



STATE BUDGET STATUS

PA General Assembly session update

- The Senate and House returned to session in mid-September but not during the same weeks. There has been little progress in completing the remaining 2023-2024 state budget related legislation: the various code bills to permit budget line items to be spent including the fiscal, administrative, school and tax codes, the higher education non preferred legislation bills for Pitt, Penn State, Temple and Lincoln and various other budget issues.
- On August 3, 2023 Governor Shapiro signed HB 611 however State Budget Secretary Uri Monson told legislative leaders in August that he would not release roughly \$1.1 billion for a number of programs without additional legislation being approved by state lawmakers.
- On August 30, the Senate returned to session to consider a few pieces of legislation including two Fiscal Code bills which must be enacted to allow previous approved state budget appropriations to be allocated: HB 1300 and SB 757.
- HB 1300 and SB 757 were sent to the PA House and the House adopted significant changes to HB 1300 as well as approved a Tax Code (HB 1219), Public School Code (HB 27) and a supplemental appropriations bill (HB 1456).

The Tax Reform Code Bill includes the following provisions:

- Combined Reporting: Implements combined reporting for the Corporate Net Income Tax (CNIT) by requiring a corporation that is a member of a unitary business consisting of two or more corporations pursuant to a "water's-edge basis" to file a combined annual report to the Department of Revenue beginning in tax year 2025. Effective for tax years beginning after December 31, 2024
- CNIT Rate Reduction: Reduces the CNIT rate to 4.99% based on the following schedule: 7.99% for tax year 2023 6.99% for tax year 2024 5.99% for tax year 2025 4.99% for tax year 2026.
- Expansion of Net Operating Loss (NOL): Increases the NOL deduction for corporate taxpayers from the current 40% of taxable income to 80% of taxable income using the following schedule: 50% of taxable income for tax year 2024 60% of taxable income for tax year 2025 70% of taxable income for tax year 2026 80% of taxable income for tax year 2027
- Qualified Manufacturing Innovation and Reinvestment Deduction: Lowers the minimum private capital investment
 from \$60 million to \$50 million and establishes new project completion requirements based on the total private
 capital investment of the project. The bill also allows taxpayers with at least \$50 million in private capital
 investment for a project entitled to a 25% deduction, where they can deduct up to 5% a year over the succeeding
 10 years and creates a tax incentive for taxpayers to commit to more than two concurrent projects. Effective for
 tax years beginning after December 31, 2023

Tax Reform Code

Included in the Tax Code bill approved by the House was a provision increasing the transfers made to the Public Transportation Trust Fund from Sales and Use tax Revenue from 4.4% to 6.4% beginning in FY 2025-2025. It is estimated that an additional \$311 million will be transfer to this account based on projected SUT collections (of this amount Pittsburgh Regional Transit would receive \$60 million).

Fiscal Code

Included in the Fiscal Code legislation was language relate to transportation and infrastructure which should be noted:

- Electric Low-Speed Scooter Pilot Program requires the City of Pittsburgh to adopt an ordinance and executive order authorizing the program by December 31, 2023. An executive order by the City of Pittsburgh may be issued to authorize the use of electric low-speed scooters under a micro-mobility project, for use within the city boundaries. This article does not prevent PennDOT, on state highways, or local police, on city streets, from exercising their powers.
- Updates language surrounding the Keystone Opportunity Zone/Keystone
 Opportunity Expansion Zone/Keystone Opportunity Improvement Zone Act.
- Extends the existing multimodal local match waiver through 2024. The statute originally requires a 30% local match.

Two other infrastructure related programs should be noted:

DCED Multimodal Grant Program

The Pennsylvania Department of Community and Economic Development accepted applications through July 31 to fund transportation improvement projects under the Multimodal Transportation Fund (MTF). Eligible applicants include municipalities, council of governments, business/non-profit organizations, economic development organizations, public transportation agencies, public airports, airport authorities, and ports and rail entities. Funds may be used for the development, rehabilitation and enhancement of transportation assets to existing communities, streetscape, lighting, sidewalk enhancement, pedestrian safety, connectivity of transportation assets and transit-oriented development. The current plan is for the Commonwealth Financing Authority to consider these applications and possibly make awards at their November 21 meeting.

PennDOT Multimodal Grant Program

On September 25 PennDOT began accepting applications for the next round of funding for grants under the Multimodal Transportation Fund. Applications are due by 4PM on November 10, 2023. PennDOT expects to announce grant recipients next year for funding that will be available in July 2024.

Governor Shapiro's Economic Development Proposal

Governor Josh Shapiro, Department of Community and Economic Development (DCED) Secretary Rick Siger, and Chief Transformation Officer Ben Kirshner, (newly created)Office of Transformation and Opportunity, announced the creation of the Commonwealth's first comprehensive economic development strategy. Governor Shapiro and his Administration have been working to grow and reignite Pennsylvania's economy. The strategy will be an assessment of the Commonwealth's areas of strength and an analysis of barriers to growth, concrete goals and initiatives to guide policymaking and future investment decisions.

The economic development strategy will articulate plans to address some of the following key elements:

- Simplifying the landscape of available programs and incentives available through DCED and growing a smaller set of essential tools that will be the most useful;
- Streamlining the process for businesses relocating or expanding in Pennsylvania, including through the work of the newly created Office of Transformation and Opportunity;
- Addressing the lack of "shovel ready" sites to attract new business to the Commonwealth and retain existing companies that require space to expand and grow;
- Doubling down on areas of strength in high-growth sectors like life sciences, agribusiness, manufacturing, technology and robotics, and energy, and providing targeted and focused support to these vital industries;
- Encouraging the creation, growth, and sustainability of small businesses in Pennsylvania;
- Supporting strong communities for businesses and workers through revitalizing and addressing the challenges facing Pennsylvania's downtowns, Main Streets, and Elm Streets; and much more.

The Shapiro Administration began holding listening sessions with business and economic development leaders in every region of Pennsylvania during the creation of the strategy.
