Transportation Improvement Program (TIP) Update

2025-2028 TIP SCHEDULE

Fall 2023 (through end of this year)

- TIP Workgroup meetings (20) and project selection for Draft 2025-2028 TIP-Completed
- TA, CMAQ, and CRP Projects selected via competitive application processes-Completed
- First round PPP and Public Meetings for feedback-Completed

Winter 2023/2024

 Pre-Draft TIP completed and forwarded to PennDOT Central Office for revie-Completed-PennDOT review ongoing

Spring 2024

- PennDOT review; AQ Conformity & EJ Analysis; document preparations-Started
- Smart Transportation Program solicitation Application period open
- 30 Day Public Comment Period-including 11 public meetings (May 9-June 7) and Comment/Response documentation - Meetings being scheduled
- 2025-2028 TIP adoption at June, 2024 Commission meeting

SPC Administered Program Federal Funding (STU)

Type: Reimbursement

Match: 20% non-federal (per project phase requested)

Available Funding: \$3 million/year, region-wide. Projects selected by competitive application process every 2 years. Planning studies and design proposal requests may not exceed \$250,000. Construction proposals may not exceed \$1,000,000, including construction inspection.

Other: Mixing of federal and state transportation funds, with differing matching requirements, within same project phase is *highly discouraged*

SPC Administered Program Federal Funding (STU)

Eligible Sponsors: SPC member county governments and the City of Pittsburgh may submit one project each, PennDOT Districts 10, 11, and 12 may submit one project per county in their district

Eligible Activities: Planning studies, preliminary engineering, final design, and construction (plus inspection)

Eligible Project Categories:

- Bicycle/Pedestrian Improvements
- Corridor Management/Congestion Reduction
- Intermodal/Transit Oriented Development
- Planning and Redevelopment
- Road/Intersection/Network Improvements
- Streetscapes/Traffic Calming
- Electric Vehicle Charging Stations



2024 Application Evaluation:

- SPC staff will evaluate projects using five STLC Transportation Themes:
 - Linking transportation investment and land use planning
 - Supporting Community Goals
 - Multimodal approach
 - Safety
 - Sustainability
- Other factors
 - Consistency with goals in our Long Range Plan
 - Partnering/collaboration on application
 - Environmental Justice
 - Funding/Project readiness

Program Process Timeline for the 2025-2028 TIP	
February 15, 2024	February TTC Mtg; Application period opens
March 4, 2024	Pre-qualification applications due to SPC
March 8, 2024	Sponsors notified if candidate projects meet requirements and are invited to submit final application
April 8, 2024	Final application period closes
April 8, 2024 – May 3, 2024	Project evaluation and selection process
May 9, 2024	TTC endorses project list
June 24, 2024	SPC TIP Adoption



Metrics & Performance


- 7,300+ attend robotics events
- 1,000+ students started robotics & tech based training
- 30+ started work based training
- 10+ coal impacted started training
- 50+ enrolled into pre-apprenticeship
- Supportive services provided (gas cards etc.)
- Mitigation teams formed (removing barriers to employment)
- Data tracking rural, urban, demographic and equity
- Still lots of work to accomplish over remaining grant

Challenges/Solutions – Year 1

- New classes have smaller turnouts
 - Expected Increase in the semesters/months following
- Staff turnover across sub-awards
 - Consistency in forms, processes and reporting
 - Frequent check-ins
- Competing priorities new grants
 - Opportunities for partnership
 - Look for alignment vs opposition
- Perceived Limited opportunities under "robotics"
 - Expanded training to robotics adjacent careers better communication of what robotics is to the community
- Reporting Standardization not always conducive to project size
 - Working to determine best practices for larger scale projects

- 900 students & 77 teachers from swpa schools
- Robotics Talent Acquisition & Retention Workshop (50+ in attendance)

Interagency Working Group on Coal and Power Plant Communities

- The Biden Administration established the Interagency Working Group (IWG) of federal agencies to facilitate economic revitalization in coal, oil and gas, and power plant communities and to support displaced workers.
- The IWG is co-chaired by the Director of the National Economic Council (NEC), the National Climate Advisor (CPO), Senior Advisor in Office of Clean Energy Innovation and Implementation (OCEII)
- The IWG is administered by the Secretary of Energy.



Interagency Working Group on Coal and Power Plant Communities

Establishment of Pennsylvania Rapid Response Team led by US Environmental Protection Agency Region 3

- Provide assistance to communities to address economic revitalization, worker needs, and related issues
- Connect communities to the Federal agency with funding to address opportunities for economic revitalization
- Make connections with state and local leadership
- Hold meetings with community members and stakeholders

IWG Working Meetings - Timeline

- August 2023: EPA reaches out to Energy Communities in Pennsylvania; five of six are located in Southwestern Pennsylvania
- August 2023 RRT concept presented to SPC Board
- September 4, 2023: Scheduling of virtual listening sessions
- Pennsylvania Energy Community Virtual Listening Sessions scheduled and held:
 - September 18, 2023: Washington County
 - September 19, 2023: Greene County
 - September 21, 2023: Beaver County
 - September 22, 2023: Armstrong County
 - Indiana met individually with IWG partners



October 20, 2023: IWG Culmination Event – Westmoreland County Community College

SPC as the Regional Convener

Natural fit for outreach and stakeholder engagement

- LDD, EDD and MPO
- Deep ties to the region through planning activities CEDS, LRTP, TIP
- 50+ member Commission/Board (County Commissioners, State, Transit etc)
- Partnerships for Regional Economic Performance (EDOs & Small Business)
- Community Capacity Program
 - Local Government, Education, Non-Profits etc.
 - Requests for funding show regional needs

Key Take-Aways from September

- Overall needs:
 - Capacity building to apply for federal grant opportunities
 - Planning grants for feasibility studies, blight studies, housing needs
 - Funding for blight, broadband, water, infrastructure, housing, business attraction, workforce attraction and retaining population are needed
 - More conversations are needed
- Things to Note
 - Planning Directors & EDOs did an amazing job presenting
 - First time grant applicants and limited support
 - Low unemployment rates are not indicative of success
 - Separation of ideas vs projects (shovel ready application ready)
