NOTICE OF PUBLIC COMMENT PERIOD AND PUBLIC MEETINGS



The Southwestern Pennsylvania Commission (SPC) is seeking input from the public on the following draft documents during the public comment period which begins Wednesday, May 8 and lasts until Friday, June 7:

- *2025-2028 Transportation Improvement Plan (TIP) which plans for the region's short-term infrastructure and transportation projects*
- *Environmental Justice Benefits and Burdens Assessment of the Draft 2025-2028 TIP*
- *Air Quality Conformity Determination for the Draft 2025-2028 TIP*
- *Amendment to the region's long-range transportation plan (LRTP) (Appendix IV-1) to reflect updated transportation revenue projections and revised project list*

Beginning May 8, 2024, these draft documents will be available for the public's review at www.spcregion.org.

Our organization encourages members of the public to review the draft documents and attend an upcoming public meeting in your community to learn more about our region's transportation and infrastructure planning process. These meetings will be conducted in an open house format. There will be opportunities to review maps, and speak with SPC staff members, representatives from your county planning department, PennDOT representatives, and local transit operators.
