Health Sciences Cluster at IUP



- Health Sciences Cluster includes the **College of Health Sciences** and the proposed **College of Osteopathic Medicine** to be physically located in three existing buildings on the Indiana campus.
 - The College of Health Sciences Academic Departments include:
 - Nursing UG, Masters and PhD programs
 - Allied and Public Health UG and Grad programs in athletic training, exercise science, medical technology, medical imaging, nutrition, public health, respiratory care, and speech language pathology,
 - Psychology UG and PsyD programs
- The aim is to increase collaboration and to facilitate interprofessional education across the health professions with a focus on rural health.
- IUP received approval from the BOG for \$500,000 for DGS to conduct a facilities feasibility study for renovation of an existing 3-building health sciences cluster at IUP. Plans are being developed in which existing IUP facilities will be used for the Health Sciences Cluster to include Simulation, cadaver, osteopathic manipulation (OMT) laboratory spaces.



Growing health inequity

Advancements in health care have not equally benefited people living in mail parts of the U.S. where rates of death from heart disease, cancer and other problems are higher than in urban centers. Access to health care is the most pervasive health disperity in rural America, where beophals have been shrinking services.


WHILE THE NUMBER OF RURAL U.S. COUNTIES IS DECLINING ...

The Rising Cost of Western Pennsylvania's Rural Penalty

Despite decades of groundbreaking advancement in medicine, "life in rural U.S. often means lives cut short by heart disease, cancer, unintentional injuries, lung problems and stroke at higher rates than in urban areas."

- In 2004, in comparison urban counties, rural counties experienced more than 35,000 additional deaths.
- By 2016, the number number of excess deaths for rural counties, above the number of deaths expected under normal conditions, ballooned to about 61,000 annually.

This reflects an increase of 75% in the past 12 years.





3 Key Components Necessary to Move to Candidate Status




- 1. Escrow and Operating Reserve must be funded.
- 2. Development of Self Study (including feasibility and business plan) submitted and approved by COCA.
- 3. Affiliation Agreements executed for one year of clinical rotations to cover 120% of full class size (120 students)

Dr. Miko Rose, DO, FACN, FNAOME Founding Dean



Dr. Rose, a board-certified physician in psychiatry and neurology who is nationally known for wellness programming, began work as the founding dean for IUP's proposed college of osteopathic medicine in November 2023.

Dr. Rose came to IUP from Pacific Northwest University of Health Sciences College of Osteopathic Medicine, where she was Associate Professor and Chief of the Division of Psychiatry in the Department of Clinical Medicine and Assistant Dean for Clinical Education.

She was also an Associate Professor and Program Director of the Joy Initiative Wellness Program at Michigan State University. She founded and started the Joy Initiative at the Michigan State University College of Human Medicine and College of Osteopathic Medicine schools. She completed her medical training at Michigan State.

In May, she was elected as a fellow of the American College of Neuropsychiatrists by the Fellows of the American College of Neuropsychiatrists/American College of Osteopathic Neurologists and Psychiatrists. Candidates for ACN fellowship are nominated by two current fellows and are reviewed by the ACN Board of Governors. Fellows must be board certified and serve the American College of Neurologists and Psychiatrists in some capacity.

Prior to entering medical school, Dr. Rose worked as a program officer, fundraiser, and advocate for the underserved with a focus on overcoming domestic violence and trauma.

Dr. Luke Mortensen, PhD, FAHA, FNAOME Associate Dean of Pre-clinical Affairs



Luke H. Mortensen, PhD, FAHA, FNAOME, is the Associate Dean of Preclinical Affairs at the Indiana University Proposed College of Osteopathic Medicine (IUPCOM) in Indiana, Pennsylvania. Prior to his role at IUPCOM, he was founding Associate Dean of Educational Development, Innovation, and Diversity at the Idaho College of Osteopathic Medicine in Meridian, Idaho. His areas of emphasis are in Professional Development, Interprofessional Education and Practice, and Medical Education Leadership Development. From 2012-2017 he served as Vice President and Chair of Medical Education at the American Association of Colleges of Osteopathic Medicine (AACOM) engaging with their member colleges to promote teaching/learning excellence in osteopathic medical education. From 1995-2012, he was a tenured faculty member at Des Moines University in clinical pharmacology and toxicology and served as Assistant Dean and Director of faculty development. He received his doctoral training at Michigan State University and post-doctoral experience at the University of Texas Health Sciences Center in San Antonio. He is a Fellow of the American Heart Association and of the National Academy of Osteopathic Medical Educators.

Dr. Ryan Smith, DO, PhD Associate Dean of Clinical Affairs



Ryan Smith, DO, PhD, is a psychiatrist and the Associate Dean of Clinical Affairs at the Indiana University of Pennsylvania's Proposed College of Osteopathic Medicine (IUPCOM). Prior to his role at IUPCOM, he served as Associate Dean of Pre-Clinical Affairs and Professor of Psychiatry at the Orlando College of Osteopathic Medicine, and before that, was Chief of Psychiatry, Director of Year 2 Systems Based Education, and an Associate Professor Psychiatry at the University of New England College of Osteopathic Medicine in Maine. He also has practiced clinically for the past 13 years at the New Hampshire State Psychiatric Hospital/Dartmouth Medical School and has opened graduate medical education (residency) programs in New England.

Ryan now lives in Indiana borough in a home he recently purchased. His husband, Howard Pelkey, JD, taught in the Employment Relations and Hospitality Department in Eberly College of Business.

Melanie Muscatello Management Technician



Melanie Muscatello is a Management Technician at the Indiana University of Pennsylvania's Proposed College of Osteopathic Medicine (IUPCOM) since April 2024. After serving as the Credentialing Coordinator at Windber Medical Center, Melanie accepted a position in the chemistry department at IUP. During her nearly 20-year career with IUP, Melanie has worked in the departments of biology and financial aid, the school of graduate studies and research, and university advancement. In 2012, she earned a bachelor of science in human resource management from the Eberly College of Business. Melanie's experience, combined with her passion for serving the university community, has given her the ability to hit the ground running in her new position.

Melanie, and her husband, Joshua, and their dog, George, live in Indiana borough. Joshua is employed by the Commonwealth of Pennsylvania and is co-owner of a local restaurant. Melanie loves taking George for walks, traveling, doing puzzles, and baking.

John A. (Jack) Brose, DO, FAAFP Executive Dean Emeritus and Professor of Family Medicine at the Heritage College of Osteopathic Medicine; Executive Mentor and Consultant to the IUP Proposed College of Osteopathic Medicine



Dr. John A. (Jack) Brose is the Executive Dean Emeritus and a Professor of Family Medicine at the Heritage College of Osteopathic Medicine (HCOM), as well as the former Vice Provost for Health Affairs at Ohio University. He holds a B.A. in Biology from Gettysburg College and a D.O. from the Texas College of Osteopathic Medicine. After completing a Family Practice residency at Scott Air Force Medical Center, where he served as Chief Resident, he achieved the rank of Major and later completed an academic fellowship at The Ohio State University College of Medicine. Throughout his career, Dr. Brose has held faculty positions at various universities, including Ohio University and St. Louis University, earning 30 teaching awards, such as the Ohio Academy of Family Physician's "Family Practice Educator of the Year Award."

From 2001 to 2012, he served as Executive Dean of HCOM, where he successfully expanded the entering class size from 100 to 250 students and raised over \$130 million for various initiatives, including a historic \$105 million grant from the Osteopathic Heritage Foundation. He was instrumental in establishing new branch campuses in Dublin and Warrensville Heights, Ohio, and created a non-profit faculty practice plan. Dr. Brose has also authored two editions of the "Guide to EKG Interpretation," published over 20 research papers, and hosted a nationwide radio program on Family Health.

In addition to his executive roles, he has consulted for the American Board of Medical Specialties on the AOA/ACGME residency merger and worked to increase African American representation in healthcare. Currently, he is involved in the HCOM Admissions Committee, teaching EKG interpretation and Cultural Medicine, and consulting with universities on creating new medical colleges. Outside of his professional achievements, Dr. Brose has been married for 52 years and is the father of two physicians.



PPP Outreach and Public Comment

- Public Participation Plan (PPP) is the official document that governs how SPC interacts with the public.
- Draft copy was sent in the meeting materials.
- Public Comment period for PPP March 3rd-April 17th.
- Transportation Technical Committee (TTC) and Transit Operators Committee (TOC) have both been briefed on the PPP and recommended its adoption.



Public Comments Survey

- Survey conducted to gauge public opinion around SPC's engagement
- SPC received 74 responses with a 100% completion Rate
 - 32% never attended or commented on a plan
 - 30% are highly involved
 - 64% that answered would describe themselves as working in the SPC region
 - 78% like to receive information about upcoming events and meetings via emails from event organizers, quarterly newsletter, social media
 - 49% said that they want to see more online meetings options
 - 42% said more outreach and volume of outreach
 - 45% said they prefer giving feedback through hybrid meetings
 - 41% said virtual
