## 4. PennDOT and FTA Updates

- a. <u>PennDOT</u>: Devon White of SPC presented updates submitted by Brandon Leach who was not in attendance
  - i. PennDOT's "Green Light-Go" Program awards announced; 73 municipalities will receive a total of over \$30 million to support signal upgrades. Grants are provided as reimbursements for operational improvements such as installation of updated technology, retiming of signals, development of special event plans, and more. List of awards can

- ii. 2024 Rail Freight Grant application period opens; Two grant programs (RTAP and RFAP) provide financial assistance for investments in rail freight infrastructure. Application is open until 4:00pm on Friday, August 30. - b. <u>Chuck Imbrogno</u>: The state transportation commission meeting is happening concurrently with the TOC. They will be voting on the new TIP and we should receive notification by EOD that it has been approved.

#### 5. TIP Amendments and Administrative Actions

a. WASH: Freedom Transit submitted one TIP amendment to allocate additional funds received from FTA's competitive Bus and Bus Facilities 5339 program in the amount of \$15m with appropriate State and Local match, and also allocating an additional \$4m of 5339 funding allocated from PennDOT with appropriate State and Local match. The amendment was approved on a motion by Ashley Seman and second by Seth Davis

#### 6. SPC Staff Updates

a. Abby Link, Toole Design: Active Transportation Plan update - Since the last plan interest and funding for safe streets and active transportation projects has increased making this a good time for an update. The update will include stakeholder engagement, existing conditions analyses, multimodal network analyses, and public engagement. Work will include a review of high level goals and objectives, a review of the existing system against national guidelines, and the creation of a design treatment toolbox and policy toolkit. Multimodal analysis will attempt to answer four questions: Which areas have low stress access to jobs, transit, businesses, and schools? How many people can access trail networks without an automobile? Where do critical gaps exist in the bike/ped network? Where is it safe and comfortable to walk, bike, and access transit? developed the Cybersecurity Assessment Tool for Transit. It's available on the FTA website but it's easiest to find just by Google searching the name. The tool is a series of files and questions for your staff to identify any software, procedures, and policies that need to be in place to protect your organization from these kinds of attacks.
