



Strategy 1: Raise the Profile of Skilled Labor Blue Collar Careers

In order to fill the increasing number of jobs in skilled trade industries, efforts must be made to break the stigma attached to available jobs in blue collar jobs (such as heavy machinery, etc.). Partner with local workforce boards to implement training that emphasizes problem solving and leadership skills to show that these jobs have opportunities for advancement.

Implement a public education strategy showing that skilled labor is a viable path to success. Encourage training in schools from early ages to both increase awareness of these trades and encourage hands-on work experience such as apprenticeships. Build partnerships with educators and employers to understand employer needs and post-secondary employment options. Place as much emphasis on skilled labor tracks as academic tracks.

Strategy 2: Focus on Soft Skill Training

Encourage training programs to focus on soft skills. Local schools and universities can develop programs that focus on soft skills and industry specific training. Schools and training programs can incorporate transition plans with employment goals into graduation requirements.

Regional partners can help expose students to a greater range of jobs to increase their awareness of career opportunities. Network with universities to secure funding to support education and leadership training to help move employees up the ladder. Provide or arrange for flexible and easy to use on-the-job training funds for companies to train employees and promote awareness of existing resources to aid with these goals.



Rochester Road (SR 3022) Widening AQ Conformity, TIP/LRP Amendment




PROJECT LOCATION

Proposed Amendment: LRTP

Proposed Amendment

PennDOT District 10 is proposing to add the Rochester Road Widening to the SPC 2025 TIP resulting in a revision of the Regional Air Quality Conformity and the amendment of the SPC TIP and SPC Long Range Plan. The proposed LRP amendment includes adding the construction phase of the project to the current LRP. The construction cost is \$15 million. Table 1 shows the proposed changes to the LRP fiscally constrained project list.

The proposed project on Rochester Road in Cranberry Township Butler County includes widening to five lanes under the PA Turnpike's Rochester Road Bridge, and widening of Rochester Road (SR 3022) between Haine School Road and Thompson Drive to five lanes. The project includes pedestrian/bike facilities on Rochester Road and replacement of the existing structure carrying Rochester Road over Brush Creek.

Proposed Amendment: TIP

- PennDOT District 10 is requesting to add preliminary engineering phase of the project to the SPC current TIP and program \$1,6 27,785 due the findings of the study phase. The requested amount will allow for the preliminary engineering work order to be executed. Note that the project is now intended to be developed for construction due to available funds.
- The sources for both requests will be as follows:
 - SPC District 10 Highway/Bridge Reserve Line Item: \$1,002,859 in FFY 2026 to include the study increase as well as a portion of the preliminary engineering increase.
 - Three Degree Road Intersection: \$627,758 of unneeded construction funds in FFY 2027 for the remainder of the preliminary engineering increase.




